

ORDINANCE #75-1

VILLAGE OF TONY

AN ORDINANCE REGULATING THE USE AND OPERATION OF SNOWMOBILES IN THE VILLAGE OF TONY, RUSK COUNTY, WISCONSIN, AND IMPOSING PENALTIES.

THE VILLAGE BOARD OF THE VILLAGE OF TONY DO ORDAIN AS FOLLOWS:

SECTION I. The use of snowmobiles within the limits of the Village of Tony is prohibited, with the following exceptions:

1. Snowmobiles may be operated on the premises of the snowmobile owner.
2. Snowmobiles may be operated on other privately owned property with permission of the owner.
3. Snowmobiles may be operated on village streets within the limits of the Village of Tony only for purposes of entering and leaving the Village of Tony; such entering and leaving to be done without damaging residential and business lawns, yards, lots, etc.

SECTION II. In addition to the above provisions, the following rules and regulations shall apply:

1. Rate of speed for operation of snowmobiles shall not exceed 25 miles per hour except when being operated on the premises of the snowmobile owner or on other privately owned property with permission of the property owner.
2. No person shall operate a snowmobile anywhere within the Village of Tony between the hours of 1:00 a.m. and 8:00 a.m.
3. No person shall operate a snowmobile within an area sufficiently close to any church property so as to be disturbing on Sunday mornings between the hours of 8:00 a.m. and 12:00 noon.
4. No Person shall operate a snowmobile with any person, vehicle or sled attached to or trailing said snowmobile, except on the premises of the snowmobile owner.
5. No person shall operate a snowmobile within the Cemetary grounds at any given time.
6. The operator of a snowmobile shall yield to all vehiclar traffic when operating on or crossing a village street, alleyway, or roadway.
7. Snowmobiles shall be operated in single file and as far to the right portion of the street as possible.
8. Snowmobiles in use or operation shall be stock sleds only; the use of expansion chambers or other attachments is hereby prohibited.

SECTION III. Any person who shall violate any of the provisions of this ordinance or any rule or regulation made therein, is subject to a fine of \$25.00 for the first offense and \$50.00 for the second offense and \$100.00 for the third offense and subsequent offenses.

SECTION IV. All ordinances or parts of ordinances inconsistent or contrary hereto are hereby repealed, except nothing in this ordinance shall be interpreted so as to conflict with state laws or orders regulation the use of snowmobiles.

SECTION V. This ordinance shall take effect from and after its passage and publication.
