Old Business / Updates / New Business

- **Water operator review:** Jeff provided board members with an update. He finished updating Diamond maps and added maintenance logs into Diamond maps. The heater in the pump house will likely need to be replaced before next season. Jeff believes it will last through this winter.
- **Missing Ordinances:** All ordinances are currently scanned and uploaded to the Village Drive and the Village website.
- **Snow plow update:** Snow plow truck, the transmission went out. Justin told Jeff he was picking up a new one today and would get it in the truck tomorrow, Saturday 1/9/26. Jeff and Monte are going to explain in more detail what all needs to be plowed. Jeff would like to create a map of all roads/areas that need to be plowed. We would save these maps for bids each year, so there is a clear outline for plowing. We also want to write down clear rules/expectations for plowing. Monte spent time cleaning up the snow on roads and intersections that he felt were not clean enough. Jeff noted that Brandon on

Walnut street has a trailer on the road. It is causing snow to pile up, creating a hazard. Jeff is to talk to Brandon about moving the trailer.

- **Street Sign Update:** Monte wants to start working on the street signs, if the frost is not there and they are able to get posts into the ground. Monte and Jeff plan to start on the north side. Jeff is going to make a plan of action.
- **TAEC Update:** The Village board and members of the TAEC are going to work together to update the TAEC bi-laws. Monte appointed a committee to work on the bi-laws. The committee will be Britney Mateski, Kim Groothausen, Julie Hauser, Beth Hurlebaus, and a community member to be a common liaison. The community member was suggested to be Amanda.
- **Clerk Updates:** Insurance claim for the pump house equipment has been submitted.
